

# AN INITIATIVE PETITION

Pursuant to Section 45 of the City Charter of the City of Westfield, Massachusetts

**DEDICATION OF MEALS TAX TO ROAD AND SIDEWALK REPAIR AND MAINTENANCE STABILIZATION FUND.**

## SUMMARY

We, the undersigned registered voters, demand that the City Council pass a resolution dedicating 100% of the local option meals tax revenues collected under Massachusetts General Laws Chapter 64L to the Road and Sidewalk Repair and Maintenance Stabilization Fund established under Massachusetts General Laws Chapter 40, Section 5B, effective for the first date allowed by law no earlier than the start of the fiscal year beginning on July 1, 2021.

If the City Council does not pass this measure without alteration, we demand that the measure be put to a vote of the qualified voters, either at the next regular city election or at a special election which the city council may, in its discretion, call for such purpose in accordance with Sections 47 and 48 of the City Charter.
